Environmental Precautions:	This pesticide is toxic to aquatic organisms, including fish and invertebrates. This product may contaminate water through drift of spray in wind. This product has a high potential for runoff after application. Use care when applying in or to an area which is adjacent to any body of water, and do not apply when weather conditions favor drift from target area. Poorly draining soils and soils with shallow water tables are more prone to produce runoff that contains this product. A level, well maintained vegetative buffer strip between areas to which this product is applied and surface water features such as ponds, streams, and springs will reduce the potential for contamination of water from rainfall-runoff.
