Stop agitation then add enough REVERSE™ to get rid of foam. Antifoaming: Add REVERSE™ after the first ingredient. Do not add to dry tank or before the ad-18 oz. dition of water. Some tank mix partners create more foam than others. For ingredients that cause a lot of foam to form up to 2 ounces per 100 gallons may be required to adequately control foam. Other factors such 16 oz. as temperature and amount of agitation will increase or decrease the amount of control needed. STORAGE AND DISPOSAL **STORAGE:** Store in a cool, dry place.
