DIRECTIONS FOR USE

THIS PRODUCT IS A CONCENTRATE AND MUST BE DILUTED BEFORE USING

This product is a specifically formulated combination of sulfuric acid and wetting agents that is recommended for end-of-season cleaning of structures to create a healthy, sanitary environment for new crops being established

GREENHOUSES / NURSERIES, BOTANICAL GARDENS, ATRIUMS, PACKING HOUSES, BOUQUET MANUFACTURERS

NOTE: All plants and delicate material must be removed from treated area prior to cleaning or removing whitewash from structures. Any contact with plants or other delicate surfaces could cause damage. Recommend wearing safety glasses or goggles and protective clothing while applying STRIP-IT®. When making solution, add slowly to surface of solution to avoid splattering. Solution might etch glass or damage surface if allowed to dry.

EXTERIOR / INTERIOR STRUCTURES (GREENHOUSES, STORAGES BUILDINGS, ETC.)

Remove all plants and delicate materials prior to cleaning. Spray, mop or brush surfaces with a solution of Floralife STRIP-IT®. When cleaning large areas, use large volume sprayer or pressure washer to apply Floralife STRIP-IT® solution. Thoroughly wet surface to be cleaned so that all areas are 100% covered. Do not allow solution to dry. Reapply to maintain wetness. (Solution could etch glass or damage surface if allowed to dry.) Let stand 3 to 5 minutes. Rinse all freated areas thoroughly with clean water.

WORK AREA, BENCHES, COOLERS, CONCRETE / GRAVEL FLOORS / SHIPPING PADS, FLOOD FLOORS

Follow interior structures cleaning directions. Apply to the underside of benches / equipment and areas subjected to continuous moisture to ensure complete cleaning. For lightly soiled areas use a mop or brush to apply. Allow to soak for 3 - 5 minutes. Rinse all treated areas thoroughly with clean water.

IRRIGATION LINES / DITCHES AND STORAGE TANKS

Use this procedure only when irrigation system or storage water areas are isolated from the crop. Direct contact of Floralife STRIP-1T® with plant material will cause phytotoxicity and possible loss of plants. It is important to prepare a solution of Floralife STRIP-1T® by using exact recommended rates for irrigation lines and storage tanks for safe removal of aliage and salt deposits.

Fill irrigation lines or add the solution directly to water in the storage tank and allow solution to sit for 8 - 12 hours. Flush system with clean water until there is no visible soap foam at the farthest end of the line. If dosing Floralite STRIP-IT® into the lines, use a higher recommended dilution and let sit for 1 - 2 hours only, then flush system with clean water. Storage water lines should be drained and rinsed. Remove any large debris prior to filling with fresh water.

WHITEWASH SUN BLOCK COATING REMOVAL

Use large volume sprayer or pressure washer to apply Floralife STRIP-IT® solution for whitewash removal. Thoroughly wet surface to be cleaned or stripped with the Floralife STRIP-IT® solution so that all areas are 100% covered.

Allow the solution to remain wet on the surface for 3 - 5 minutes. Do not allow solution to dry. Reapply to maintain wetness. (Solution could etch glass or damage surface if allowed to dry.)

Use a pressure washer or high pressure hose for easy rinsing and removal of whitewash. Use plenty of clean water to remove all traces of the Floralife STRIP-IT® solution.

APPLICATION METHODS

High-pressure sprayers or pressure washers are recommended for removal of deposits and whitewash, and for rinsing. Low-pressure sprayer, mop, or brush can be used for lightly soiled areas. Follow recommended use directions. Safe to use on structures, floors, benches, coolers and equipment composed of materials such as aluminum, copper, galvanized steel, plastics, polycarbonate, fiberglass and concrete. DO NOT allow use of Floralife STRIP-IT® to dry on aluminum, tin, galvanized iron, glass, etc. or etching could occur. Rinse thoroughly.
